

Privacy Statement LTO Network

Introduction

1. LTO Network B.V., a private limited liability company organized and existing under the laws of Curaçao, having its corporate seat at Curaçao, with address Landhuis Groot Kwartier Groot Kwartierweg 12, Curaçao, registered at the trade register of the Chamber of Commerce for Curaçao under number 148977 (hereafter "LTO Network"), attaches great importance to the responsible handling of personal data of users of its website livecontracts.io (hereafter "Users").
2. LTO Network processes personal data of Users carefully and with due observance of the provisions of the EU General Data Protection Regulation (GDPR).
3. In this Privacy Statement, LTO Network informs Users about the way LTO Network processes their personal data and how they can control this process. This Privacy Statement only applies to the services offered by LTO Network on <https://lto.network/>

Article 1: Explanation of personal data and goal for the processing thereof

Personal data

1. LTO Network collects email addresses, full names and address details (hereafter "**Personal Data**") of individuals who decide to buy LTO Network cryptographic tokens (hereafter "**LTO**") via the website <https://lto.network/>. These are data that can be linked to the identity of an individual person.
2. LTO Network is at all times responsible for the management of the Personal Data provided by each User and will make every effort to protect these Personal Data. In the event of a data breach, LTO Network will immediately inform the User of that event via the email address known to it and make every effort to prevent further distribution of these Personal Data.
3. The User has the right at all times to receive the Personal Data provided by him / her to LTO Network in an orderly manner from LTO Network ("right of access"). On the first request of a User, LTO Network will forward his / her Personal Data to a third party to be designated by that User ("right to data portability") or remove it entirely from its system

("right to be forgotten").

4. Any questions that a User may have regarding his Personal Data can be asked to support@ltonetwork.com. These questions will be answered within 2 working days at the latest.

Goal

5. LTO Network requires Personal Data from a User to enable that User to buy LTO. LTO Network will not use Personal Data for any other purpose, unless the User has explicitly given permission for another use of these Personal Data.

Permission

6. To receive, process and use Personal Data of a User, LTO Network requires the User's permission. This permission is granted by a User by agreeing to provide his Personal Information in order to buy LTO.

Fraud, infringement or other unacceptable behavior customers

7. If necessary, LTO Network will use Personal Data to investigate, prevent and counter fraud. Upon request, LTO Network will hand over Personal Data to the relevant judicial authorities or other investigative services or involved third parties, if it is obliged to do so by virtue of the law, a court judgment, or if this is necessary to prevent offenses or wrongful conduct.

Article 2: Transfer to third parties

1. LTO Network does not give Personal Data of Users to third parties.

Article 3: Data security

1. LTO Network makes use of appropriate technical and organizational security procedures, among other things to ensure that unauthorized persons do not gain access to Personal Data and to prevent the loss, unlawful use or modification of Personal Data.

Article 4: Availability and modification of your data

1. Users can request access to their Personal Data at any time. Users may also request that their Personal Data be changed or deleted by sending an e-mail to support@ltonetwork.com

Article 5: Cookies

1. LTO Network uses cookies on its website as mentioned in its Cookie Statement.
